PCA WEST VIRGINIA RECOGNIZED FOR CHILD SEXUAL ABUSE ADVOCACY

Our state chapters are the lifeblood of PCA America, and we're proud to have such a talented and dedicated network of experts advancing our mission across the country. In 2018 Jim McKay, State Director of Prevent Child Abuse West Virginia, was honored by the West Virginia Child Advocacy Network (WVCAN) with the well-deserved *Partner with Courage Award*, recognizing his work on child sexual abuse in the Mountain State.

McKay has been a steadfast leader on the West Virginia State Task Force on the Prevention of Sexual Abuse of Children and helped spearhead the legislative efforts stemming from the 2015 passage of Erin Merryn's Law, which requires that all public schools in each adopting state implement a prevention-oriented child sexual abuse program. According to WVCAN Executive Director Emily Chittenden-Laird:

HFA BY THE NUMBERS

Healthy Families America (HFA) is the nationally recognized, evidence-based home visiting program of Prevent Child Abuse America. By supporting parents in the home, HFA builds a strong foundation for safe, nurturing, and trusted relationships between caregiver and child that maximizes opportunities for children to reach their full potential and enjoy lifelong success. Families who voluntarily enroll in HFA work one-on-one with a family support specialist and receive services tailored to their specific needs. Parents can enroll in the program starting prenatally or at birth, and receive support up until the child is five years old.

Started in 1992 with fewer than 25 sites, there are now nearly 600 HFA affiliates nationwide, delivering approximately one million home visits every year. Numerous studies prove that HFA, grounded in an infant mental health approach and guided by attachment theory, helps parents and children by:

- Increasing positive parenting practices
- Reducing child maltreatment
- Improving child health
- Strengthening family economic self-sufficiency
- Reducing juvenile delinquency, family violence & crime
- Improving maternal health
- Improving child development & school readiness
- Increasing linkages & referrals

ANNOUNCING HEALTHY FAMILIES ISRAEL

In August we announced Healthy Families Israel, the culmination of nearly a year of close coordination with leaders from Youth Futures, Inc., a subsidiary of the Jewish Agency for Israel (JAFI), and their partners at Digma Applied Evaluation and the University of Haifa. Before selecting HFA, the organizations conducted a review of more than a dozen different evidence-based home visiting models, ultimately choosing HFA for our solid foundation and flexible programming. Youth Futures Director Liat Riff explained, HFA is "so professional, and they have all these tools, and a great evidence base...They were willing to work with us, to understand us, and make sure it was a good match."

Their team is off to a good start: families have already begun to be recruited and visited in six pilot communities, serving both Jewish and Arab sectors, and plans are underway to expand to more localities countrywide. We are grateful to our newest friends and colleagues for what we predict will be a long and mutually rewarding relationship that improves the lives of families and children throughout Israel.



HEALTHY FAMILIES AMERICA INTRODUCES CHILD WELFARE ADAPTATION

Although HFA works with all families, the program best serves parents who are high-risk and overburdened, including individuals who have been involved in the child welfare system. There is a recognized value in connecting high-risk families to intensive home visiting services such as HFA, however, challenges arise when families with older infants or toddlers are identified, and HFA services are unavailable due to the child's age.

We've addressed this gap by introducing the HFA Child Welfare Adaptation, whereby families referred by the child welfare system are now able to enroll in the program until the child reaches 24 months of age. Similar to the current HFA model, support services are offered for a minimum of three years—regardless of the age of the child at intake—and tailored to the unique needs of each family.



PUBLIC POLICY HIGHLIGHTS

Prevent Child Abuse America advocates for polices and legislation that promote healthy child development and prevent abuse and neglect before it happens. Our dedicated public policy team operates in Washington, DC, mobilizing support for federal programs and initiatives. Acknowledging the value of collaboration, we partner with more than 50 professional organizations, including the Children's Leadership Council, the National Child Abuse Coalition, and the National Home Visiting Coalition, to amplify and maximize our efforts. We also work closely with our nationwide chapter network and Healthy Families America sites across the country, enabling us to facilitate effective advocacy and provide technical support at the state and local levels, too.

MIECHV REAUTHORIZATION

This year the PCA America public policy team and allied organizations successfully advocated for the long-term reauthorization of the Maternal, Infant, and Early Childhood Home Visiting (MIECHV) Program, which supports overburdened families at risk for adverse childhood experiences (ACEs). On February 9, 2018, Congress passed a bipartisan spending bill that reauthorized funding for MIECHV, providing \$400 million each year for five years for states to maintain and expand evidence-based home visiting programs, including Healthy Families America. MIECHV holds states accountable for achieving successful outcomes over time with families enrolled in benchmark areas such as improved maternal and newborn health; reduced child injuries, child abuse, neglect or maltreatment, and emergency department visits; improved school readiness and achievement; reduced crime and domestic violence; improved family economic self-sufficiency; and improved coordination and referrals for community resources.

PASSAGE OF FAMILY FIRST PREVENTION SERVICES ACT

In partnership with our national coalition, PCA America aided in the creation, passage, and implementation of the Family First Prevention Services Act (FFPSA), which was signed into law in 2018 as part of the Bipartisan Budget Act. FFPSA reforms the federal child welfare financing streams, Title IV-E and Title IV-B of the Social Security Act, to provide services to families who are at risk of entering the child welfare system. The bill aims to prevent children from entering foster care by allowing federal reimbursement for mental health services, substance use treatment, and in-home parenting skill training. It also seeks to improve the well-being of children already in foster care by incentivizing states to reduce placement of children in congregate care.

RESEARCH

PCA America translates the latest child abuse and neglect research into practice, which helps to strengthen our programs and resources and promote best practices in child maltreatment prevention. In 2018 Dr. Bart Klika, our Chief Research & Strategy Officer, launched monthly "Research Reviews," bite-sized video digests of emerging topics related to child abuse and neglect prevention, including emerging science on corporal punishment, environmental factors and the intergenerational transmission of child maltreatment, social norms, and infant safe sleep.

Additionally, Dr. Klika presented at more than half a dozen national and international conferences, including the 22nd Congress of the International Society for the Prevention of Child Abuse & Neglect, in Prague, Czech Republic; and a co-presentation with Christopher Lolley, Executive Director of PCA Florida, at the National Academy on Violence and Abuse Conference, in Tallahassee, Florida.





PUBLIC AWARENESS

In order to change the conversation around prevention and drive meaningful action, PCA America implements awareness-raising initiatives through high-impact national campaigns and state-level activations. These initiatives help uncover and change social norms and inspire and foster action on behalf of children and families.

In April, National Child Abuse Prevention Month, PCA America launched its *Help Great Childhoods Happen* campaign, which highlighted how everyone can play a role in creating the safe, stable, and nurturing relationships and environments that are central to great childhoods. The integrated campaign encouraged the public and partners to help raise awareness for child abuse prevention and provided ways to get involved in their local communities.



Launched in 2008, the campaign began as a grassroots effort for individuals and organizations across the United States to take action. The blue pinwheel is the nationally recognized symbol for prevention, representing the great childhoods all children deserve and the prevention efforts that help them happen.
